DOGS ELIGIBLE TO ENTER

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited registration, Purebred Alternative Listing/ indefinite Listing Privileges (PAL/iLP), an AKC Canine Partners listing number or approved Foundation stock service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/indefinite Listing Privileges (PAL/iLP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate, aggressive dogs, or dogs suffering from an injury, or illness which may affect the dog's physical or mental performance may Not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

No entries will be accepted by phone, email, fax, or hand delivery. express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Sara Pruyne at dtcmsentwork@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Illegible entries will not be processed and will be returned to the exhibitor. Checks will not be cashed until after the trial date and the trial secretary will add a \$25.00 collection fee to the amount of each returned check. If you do not get into the trial, your check will be safely destroyed (unless you make other arrangements with the trial secretary).

WAIT LIST INFORMATION

Dog Tracking Club of Maine (DTCM) member's work vouchers will be honored for entry. DTCM is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 10 entries per day will be placed on the club's wait list. All entries, including wait listed entries, must be received by the trial secretary before August 14 2021. No entries may be withdrawn with a refund after closing on August 14, 2021. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. Any waitlisted entry that does not move off the waitlist into the trial will receive a full refund.

STAGING AREA, HANDLER'S BRIEFING, and WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting area, as well as the steward table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A **warm-up area** will be available consisting of one container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog.

SEARCH AREA and RING CONDITIONS

Search areas may be of any shape, and of the size specified in the regulations for each class.

Search Area Conditions. Searches may be outdoors, indoors, on concrete, wooden, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes be sure to read the most recent Regulations for AKC Scent Work for your class search area size. You can order copies or download from AKC scent Work's website .

IMPORTANT ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5, Section 26 of the Scent Work regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Spectators are encouraged at the judge's discretion. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be asked to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Tent and RV camping on-site with RV electric hookup is available. Camping will be allowed for Friday night and Saturday night. If you are interested in RV parking or tent camping email k9@virginiahowe.com for more information about cost and space. No crating space will be available. You are expected to work from your cars. Bring appropriate covering for sun or rain to keep you and your dog comfortable. Food or beverages are not available for sale. Parking could be tight and there are minimal sources to purchase food so consider bringing lunch and snacks for the day. There are 2 restrooms and showers on-site. You should bring your own drinking water for you and your dog. You may be required to stage your car in different areas of the fairground

throughout the day. You may be required to walk some distance from search area to search area. The site is on a slight hill and is covered with gravel roads/paths and grassy areas. This year's fair dates are July 19–21 which is 4 weeks before this event. There will likely be animal smells and other distractions throughout the fairgrounds. Contact the trial secretary if you have any concerns or additional questions.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds .

RIBBONS and PRIZES

Placement ribbons will be awarded in each class as follows:

First Place.....	Blue
Second Place.....	Red
Third Place.....	Yellow
Fourth Place.....	White
Qualifying score.....	Dark Green

A New title prize will be awarded to all dog and handler teams finishing a title.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

CLASS ELIGIBILITY

Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and who have never worked as professional detection dogs.

Novice B Classes are open to all dogs.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Dog Tracking Club of Maine and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Dog Tracking Club of Maine reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Dog Tracking Club of Maine or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause

beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number and class running order. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

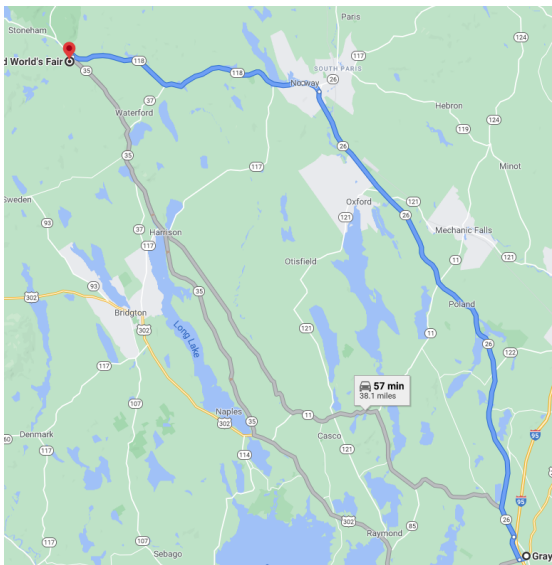
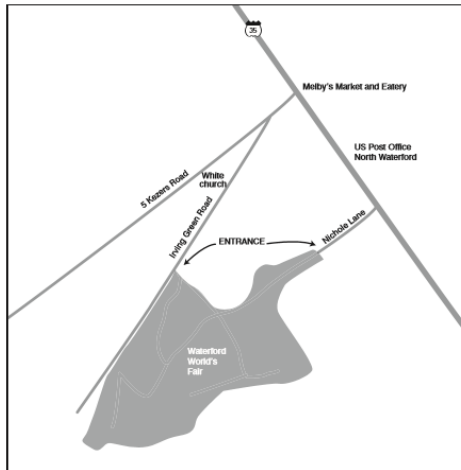

Take I-95 At Exit **63**, Turn **left** onto **ME-26A** toward **Bethel / Oxford**; Turn **right** onto **ME-26A / Maine Wildlife Pkwy**, then Bear **left** onto **ME-26 / Shaker Rd** (19.8 mi); Keep **straight** to get onto **ME-121 / ME-26 / Main St** (6.2 mi); Turn **left** onto **Main St – towards Stephens Memorial Hospital** (0.3 mi); Keep **straight** to get onto **ME-118 / ME-117 / Main St** (2.1 m); Keep **straight** to get onto **ME-118 / Waterford Rd** (10.9 mi); Take a sharp **left** onto **ME-35 / Valley Rd** (0.2 mi); Turn **right** onto **Five Kezars Rd**, then immediately bear **left** onto **Green Rd**
