NOTICE TO EXHIBITORS

The drawing will be random and will determine which entries will participate. Preference will be given, however, to dogs who have not previously earned a TDX. One worker draw will be used for this test in accordance with the parameters set forth in Ch. 1, Sec 13d of the Tracking Regulations and as determined by the Board of Directors.

WHEN THE ADVERTISED LIMIT OF ENTRIES has been drawn, all remaining entries, subject to the same preference set forth above, shall be drawn for a position on the Alternate List, corresponding to the order in which they were drawn.

The test secretary will notify all entries of the results of the drawing by mail or email if a valid email address has been provided. Entrants may call the test secretary (207-458-7968) until 8:00 p.m. concerning the results of the drawing.

Updated Covid information will be available the week before trial and sent to all participants by email.

ENTRY FEE: \$125

(Includes AKC \$3.50 recording & in event fees)

ALL ENTRY FEES PAYABLE IN U.S. FUNDS ONLY. Checks or money orders payable to **The Dog Tracking Club of Maine.**

WITHDRAWALS: *In the event an accepted entry withdraws after the Closing Date to allow an alternate to replace said entry, the entry fee will be refunded. In the event an accepted entry withdraws after the closing date and there is no alternate to replace said entry, the entry fee will not be refunded. Refunds will be mailed after the test.*

BITCHES IN SEASON will be allowed to participate in the test only after all other dogs and bitches not in season have been tested.
Fields consist of gently rolling hills and farm land that may contain manure.

TROPHIES: Start Flag with DTCM Logo and Rosette, and Folding Chair

General Tracking and Cautionary Disclaimers are as follows:

No dogs are to be allowed to be "off lead" – due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any area of the tracking site.

Cancellation of Event may occur due to extreme hazardous weather conditions as determined by the Tracking Committee and Judges.
